- c. Squad 9-3 needs suspension fix, will swap out light controller from Squad 9-2.
- d. Squad 9-2 is being stripped of equipment and will be parted out or sold as-is. Engine is dead and rebuild cost is not appropriate for this old truck.
- e. Newest 6 apparatus will be washed tomorrow and displayed at open house Saturday

### 2. CIP Projects

- a. Don Derby and I are going to install the cameras at Station 3. We are coordinating the time. Schedule has not allowed for this yet.
- b. No progress on Station 1 addition at this time. Jesse (SkyHigh Woodwerx) is willing to give an estimate. Will also attempt to get bids from other contractors once have plans drawn up. No changes.
- c. No word on AFG grant for the radios yet. Checking several times per day. Prepurchasing will void the grant request.
- d. Radio repeater to be installed at tower above school by EOM, or as soon as FCC approves. May need to purchase a couple solar batteries.
- e. Applied for grant for mitigation equipment. LGFD and HFD may provide personnel to run mitigation crew. No word yet. I don't have personnel to run the chipper in our
